

TEHAMA COUNTY TRANSPORTATION COMMISSION MEETING MINUTES OF AUGUST 31, 2010

1. Call to Order: Chairman Strack called the meeting to order at 8:30 a.m. City of Red Bluff Representative was absent.
2. Approval of Minutes: Motion by Commissioner Russell, second by Commissioner Warner to approve the June 29, 2010 minutes. Carried 5-0 with 1 absent.

4. Announcements:
 - Barbara O'Keeffe announced the vacant Associate Transportation Planner position has been filled by Sean Harrasser, formerly with the Planning Department. Also, Adam Hansen has been promoted to Senior Transportation Planner.
5. Update on State Route 36 Transportation Concept Report: Laura Rose of Caltrans updated the Commission on the Transportation Concept Report progress.

Caltrans held a meeting at Madd River and Chester, which will also be considered. The goal is to provide a draft in the Spring. This will be available on the website. Summer of 2011 is the goal for the final document.

Rogers of Caltrans began with the South Avenue Project by saying it is complete. The construction for Los Molinos has begun with the underground drainage and then Arroyo Myo drainage will begin. After Labor Day, the median, bike buffer and sidewalks will begin, with asphalt following.

Commissioner Warner added there were minor traffic problems, but it is going very well.

Mr. Rogers added the signals on Arrow Myo should be completed this year.
